PLEASE READ:

1. The President, in consultation with SMCC's Finance Committee, may change the provisions of the Scrip program at any time. When changes occur, you will be notified.
2. The 50/50 split applies to all purchases starting with your very first purchase. You do not have to meet a family goal. Families receiving financial aid are encouraged to meet \$100 in profit each year.
3. Orders totaling \$1,500 or more must be prepaid.
4. There will be a \$30 restocking charge per vendor on all returns or unclaimed orders after 30 days from the date the order arrives.
5. A \$25 fee will be charged to your account for any returned checks.
6. Tuition credits will be applied to your statement. Families of graduating 8th graders or seniors at SMCC will receive a refund check in August ONLY if they do not have another family member currently enrolled or attending SMCC in the fall of the same year. Tuition credits are not refundable in all or in part with exception to graduates.
7. Tuition credits earned by a family whose student does not complete the current academic year will be designated 100% to SMCC
8. If a "Future Student" does not enroll at the selected school, all "banked" credits will be designated to the selected school.
9. This Scrip fiscal year ends April 30.
10. Scrip cannot be mailed to any participants.
