Young Five - 8th Grade Tuition Rates Quick Reference Guide

Returning students, register before March 10, 2024 to avoid a \$100 per student late enrollment fee.

Each Student after 4 is \$950 per student.

Tuition Payment Options

1. Full Payment via FACTS

If your payment is made in full on or before <u>May 15, 2024</u> you will not be charged a late fee. This applies to current families only. New families must pay in full by the May 15th deadline or 10 days after enrollment if enrollment is after May 15th.

2. FACTS – Monthly, Quarterly, Semi Annual payment plans

A FACTS payment plan must be chosen at the time of enrollment. When you register with FACTS, you will establish your payment schedule on-line with the FACTS program. Your payment schedule will need to be chosen in order to complete the enrollment process. A link to FACTS is provided on the MCES website. Service Hours

➤ Each family with students PreK-8 is required to complete 20 service hours completed at MCES related activities or non-liturgical activities within St. John, St. Mary or St. Michael between July 1 and June 30 or \$200 charge will be applied to your account.

Fundraising - Raffle

As part of the tuition commitment and in addition to the tuition rates listed above, PreK-8 families are required to sell \$300 worth of Fall Raffle Tickets or a charge of \$300 will be applied to your tuition account.

Preschool Latchkey

- This year, preschool latchkey before or after school is available to only preschool students on the day they attend FULL DAY Preschool (5 or 3 days) and is open 6:30am-7:45am and again from 2:30pm-6:00pm.
- If you purchase the 15 non-school days, you will also receive latchkey when school is closed. Latchkey only closes on the Friday before Labor day, Labor Day, Thanksgiving and the Friday after, Christmas Eve through New Year's Day, Good Friday, Easter Monday and Memorial Day.
- Payment for tuition and latchkey are *billed through FACTS separately*. Latchkey is billed on the 1st of the month and is due on the 30th. Latchkey payment is by billed through FACTS. You can sign up for autopay or login to your FACTS Family POrtal to make a payment before the due date.
